# TIPPECANOE COUNTY TUBERCULOSIS ASSOCIATION COLLECTION

## AGENCY HISTORY

The organization of the Lafayette Society for the Prevention of Tuberculosis was spearheaded by local salesman, Charles W. Ebel in 1908. Mr. Ebel was chosen corresponding secretary and Prof. Severance Burrage served as president of the first Board of Directors of the society. Later, the society was renamed the Tippecanoe County Tuberculosis Association.

The association was reorganized in 1921 when it was incorporated under state laws.

From its earliest years the group actively worked for the eradication of the dreaded "white plague" from the local area. The annual Christmas Seal campaigns produced financial support for the association's efforts.

The Lafayette Society for the Prevention of Tuberculosis advocated the erection of shacks by the Indiana branch of the Red Cross to be located on the grounds of the two local hospitals; these shacks were to allow TB patients to be treated for the disease in the local community.

In 1921 a health survey of the county was conducted in order to determine the various conditions in the local area which might contribute to producing poor health in general and cases of tuberculosis in particular. The health survey was the first of its kind in Indiana and one of the first in the nation. Murray P. Horwood, an instructor at Massachusetts Institute of Technology, was hired to conduct the survey and to produce the final report of the survey's results.

In the mid-1920s, the association maintained fresh-air camps for underprivileged children located at Rotary Park on the Tippecanoe River; the purpose of the camps was to improve the children's health, thereby increasing their resistance to TB.

In 1927 a movement officially endorsed by the TCTA was initiated to establish a tuberculosis hospital in the county. With a donation of \$140,000 by Mr. and Mrs. David Linn Ross, the effort culminated in the building of the William Ross Sanatorium, located east of Lafayette on State Road 52. (The building is presently used by Indiana Vocational Technical College.)

Several members of the local association were also active at the state level, including: Prof. Severance Burrage, Anne M. Lutz, and Dr. Stanley Coulter.

### CONTENTS NOTES

The collection is arranged in two major series. The first is the CHARLES W. EBEL PAPERS. Mr. Ebel was the major force behind the establishment of the Lafayette Society for the Prevention of Tuberculosis. He continued to be active in the organization until his death in 1950 at the age of 78. The bulk of the collection dating from 1908 to 1923 contains correspondence and other materials which originated with Mr. Ebel in his various positions as an officer of the Board of Directors. During the processing of the collection, these materials were kept together as they reflect the early vital years of the association's work, as well as, Mr. Ebel's personal involvement in the organization.

The second series is that of the TCTA BOARD OF DIRECTORS and contains business correspondence, minutes and reports from 1922 to the early 1930s with a few items to 1954. The 520 pages of news clippings (photocopied) with items from 1908 to 1956 form a valuable part of the collection.

The third series belongs to accession 88.109 and includes sheets of Christmas seals dating from 1920-1984.
