## ROSS-HENDERSON COLLECTION

### INTRODUCTION

The Ross-Henderson Collection of business records and correspondence was donated by Mrs. Harold D. Dicks of Linden, IN. The materials were stored in old barrels in the garage of Mrs. Dicks's parents; her father's business, Lafayette Roofing and Supply once occupied the old Ross warehouse on Second Street.

Included in the collection are several ledgers and account books dating from 1833 for the following local businesses:

David Ross (1806-72) operated a general store located on Main Street on the north side of Lafayette's public square.

David Ross's brother-in-law William P. Henderson (ca. 1822-88) joined him with the above business in ca. 1845.

In ca. 1869 William P. Henderson and William Ross (1845-1913) son of David and Mary Henderson Ross, joined in partnership in a wholesale grocery business.

In ca. 1880, William Ross and his brother David Linn Ross (1851-1932) formed a partnership as commission merchants for flour, feed, etc. This business continued until the mid-1890s and was located at #'s 35 and 37 South Second Street, the Purdue Block. Account books date to 1889.

Also included in the collection are invoices and receipts from numerous local businesses. [See listing of firms, persons represented on pp. 2 to 12 and 22 to 24 of inventory.]

In addition to business correspondence from firms, persons in Tippecanoe County (1869-86) [see pp. 14 and 15 of inventory], there is also business correspondence from other Indiana counties and from other states (1869-86).

Also there is correspondence regarding real estate and farming interests in Tippecanoe County and in other area counties (1877-86).

Also included is an account book containing toll records (1873-77) for the Linwood and Wildcat Gravel Road. [See p. 19 of inventory.]

Correspondence includes letters regarding the Greenbush Cemetery Association (1879-85). [See p. 16 of the inventory.]

There are also miscellaneous railroad papers such as shipping orders, rate sheets, bills of lading, etc.; also account books from several local banks. [See p. 17 of the inventory.]
