Inside cover: "Scrapbook No. 3; bought by W. S. Haggard." Believed to have been compiled by Sandford C. Cox. Items in scrapbook date ca. 1865 to 1875. Included are articles from "Indiana State Commercial," ca. 1865-67 (published in Lafayette; Sandford C. Cox was assistant editor and may have been author of articles.)

Also included are articles from "The Banner," ca. 1871 (published in Reynolds, White County, Indiana).

Also included are articles from "Daily Journal," ca. 1871-72 (published in Lafayette); newspaper carriers' New Years addresses (poems) from "Daily Courier," ca 1866-68; 1872 (published in Lafayette).

Also included are articles and newspaper carriers' New Years addresses from "Lafayette Bee" or "The Bee," ca. 1872-75 (published in Lafayette by Joseph L. Cox and his brother W. H. Cox, sons of Sandford Cox; originally published as a juvenile paper).

Subjects of articles in scrapbook are of local, regional, and national interest; a few obituaries included. (Many articles have been copied for Library files; scrapbook is in very fragile condition.)

10. Miscellaneous loose news clippings. Several are from "The Daily Courier," 1874 (published in Lafayette). Included in the folder is a sheet from the "Remington Journal," 17 January 1973, Vol. 1, No. 27 (published in Remington, Jasper County, Indiana; with S. C. Cox written on first page).

11. Printed invitation to attend Mass Camp Meeting sponsored by the Whigs of Ohio and Indiana, on state line between New Paris, Ohio, and Richmond, Indiana, 27, 28 September 1844. (Addressed to Sandford C. Cox, Lafayette.)

Rough draft reply to above invitation, [?] September 1844 from Sandford Cox, Lafayette.

Printed leaflet addressed to the "Young Whigs of the United States" inviting them to attend the Young Men's Whig National Convention of Ratification in Baltimore, 2 May 1844.

12. Note addressed to "whom it may concern" from Joseph Orr, Captain of Orr's Company of the Indiana Mounted Volunteer Rangers, Parishes Grove, Warren County, Indiana, 16 August 1832 re service to John Cox, Private in Orr's Company, served 42 days in the protection of the frontier against the Sauk Indians (Blackhawk War).

Receipts (rough draft) re Israel H. Cox estate for money (a portion in Illinois funds) received from John Cox, March 1842. (2 items on one page; signed by S. C. Cox.)

Letter. Jesse L. Cox, Rose Hill, [?] to Sandford C. Cox, 18 September 1852. (Addressed to "Dear Brother"; mentions the Great Whig Convention and Celebration [sic] of the Blackhawk Treaty in Rock Island, September 1852.)
