TCHA Collection Department Report Kelly Lippie April 2020

- Met with staff from The Farm at Prophetstown to arrange a loan. This in now put on hold.
- Worked with Amy to scan and prepare materials to work on at home after the 'stay-at-home' order was issued.
- Created signs for the doors of the Arganbright Center and posted information to the TCHA website regarding hours and contact info.
- Still visiting Arganbright Center 2-3 per week for several hours to gather mail, check building and access collection items in order to answer researcher questions or supply material for Facebook posts by Leslie or Quentin.
- Rescheduled researcher visit who was supposed to come in early April to late April.
- Gathered images of downtown for Lafayette city study of making some roads 2-way streets again.
- Transcribed scans of letters in the archives.
- Using remote log-in, assessed Past Perfect on office computer to input catalog information for purses done by a volunteer just before stay-at-home order.
- Re-filing photograph catalog cards into a new order that will allow better access. Using cards
 to create index of photographs in several of the biggest photo collections that, until now, have
 an unknown number of prints and unknown content.
- Compiled possible loan items list for IU traveling exhibit being developed.
- Sent out loan renewals to 2 collections currently on loan to TCHA: the Masonic items at the History Center will be renewed for another year and a powder horn that would have been returned this month will be extended on loan to the end of the year.
- Accepted new donation of material to be considered by the Collections Committee when it next meets.
- Sent out Collections newsletter (to library & collections volunteers) to keep them posted on developments. Have stayed in touch with many of them.
- Began researching for article for the next membership newsletter.
- Meeting with principal of Jeff High School to give advice on the movement and storage of their mini-exhibit of firearms and Native American artifacts.
- Sent out invoice for an order of digital image copies.

Exhibits

• Exhibit change-out plans on hold pending a return to open hours. Research continues and label writing will also continue.

Social Media

• Continuing to post original material on Instagram and Twitter and to use this as a platform to communicate our hours and program cancelations. Number of followers continues to increase.

Collections Committee

• April meeting canceled, Deaccession items from May will be postponed until Board meets in person again. May collections committee meeting will also likely be canceled.

Questions for Craig for Board Meeting

History Center

- Boiler is scheduled to be shut down Tuesday, April 21st. Craig to discuss with Kelly regarding temperature requirements if no heat available after boiler is shut down.
- Megan is working from home. Does come in to use copier. Does Megan have access to Member Planet from home?
- No rental events are scheduled in the History Center between now and July 1st. 1 cancellation for July is being moved. Have there been any inquiries about rentals wanting to book later in the year?
- The Gathering church is not meeting on Sunday. Are they still paying some kind of rent? If so, how much (dollars)? Are there others who are currently paying any kind of rent in the History Center?
- What is being done to discontinue trash pickup? How much is this saving? Isn't Fowler House supposed to be paying for Arganbright trash dumpster? Craig was going to contact Fowler House to make sure payment was switched over been done?
- Have the ice machine and refrigerators been unplugged?
- Are there any other services or utilities that can be discontinued at the History Center?
- How often is the collection stored in the History Center checked?
- We were paying for 21 hours per week of cleaning of HC, Arganbright and Battlefield. How is this justified if these buildings are shut down? If no longer paying for 21 hours per week, how much are we paying for hours? Who is supervising maintenance work being done if no one is in HC or Arganbright?
- How else can expenses be decreased?

Arganbright

- Who is coming into Arganbright and how often?
- How is grass cutting at Arganbright going to be paid for in the coming months?
- How else can expenses be decreased?

Expenditures

• What is "inventory assistance" and "weekly maintenance cleaning" that is being done at the Battlefield? How many hours/week are we paying for hourly help to do this if this building is shut down?

- Is there any scheduled maintenance that can be deferred for at least 6 months? (HVAC, copier, equipment
- Craig has been told to obtain administrative password for all TCHA computers from the computer service company so we can make administrative changes to the computers without having to pay a computer company to do so. Has this been done?
- Craig was going to call Community Foundation to find out what kind of accounting review information is needed for grants on 4/15. Was that done? Can the scheduled accounting review be postponed until next year? Need to notify the accounting firm who is scheduled to do the review ASAP!
- What professional dues or membership renewals can be postponed?
- Are there any contracts that can be terminated?
- Craig was going to discuss with staff at staff meeting how office supplies and cleaning supplies can be reduced. Don't need to be cleaning the buildings if no one is using them and they are not open. What has been done to reduce this?

Feast

- What expenses can be postponed until later (closer to the Feast)?
- What cuts in advertising can be done?
- Can we postpone the search for a Feast truck replacement?

Funding

- How are we going to get the remaining \$7000 from NCHS grant to pay for work done in Arganbright if on-site inspection hasn't been done yet? Inspection by whom? Does this \$7000 cover *all* remaining expense due to contractor?
- Have we gotten refund from National Group for being charged for post cards we were not supposed to have paid? When is it going to be received?
- Do we still have \$1700 tied up in Pay Pal? Has this been resolved?
- How is fund raising being done?
- Who are the "major donors"?
- How have we been communicating to our donors and sponsors? E-mail, phone, letters?
- Small business donors are being hit hard and can't be counted on to continue to donate as they have. How are alternative to these donors being identified? How are going to reach out to them?
- How are we expanding the ring of donors beyond those that we have used already?

- How are we using on-line fund raising when there is no programming going on?
- How are we ensuring the remainder of the promised Program Support pledges are paid?
- What grants are we tapping into to support museums and NFP?
- How are we finding out about available grants? What resources are we using?

Other issues

- Has a schedule been set up to ensure that someone is coming into the HC, Arganbright, and Battlefield to make sure mail is being picked up and appropriate checks on collection materials are being made?
- How have we been communicating to our membership?
- Do we have business interruption insurance (Craig Graham)? If so, what are the triggers for being able to file a claim?
- If need be, what paid positions can be replaced by volunteers?
- Is there any remodel or repair that can be put off for six months?
- Are there any bills that can be deferred *without penalty?*
- Are all bills being paid on time so no late fees are accruing?
- Are all bills possible switched over to electronic transfer and automatic payments?
