# Minutes for October 28, 2025 TCHA Board of Governors Meeting In Person at the History Center and Online via Zoom

Board President Jeff Schwab called the August 26, 2025, meeting of the TCHA Board of Governors to order at 5:17 pm at The History Center, Lafayette.

Governors attending in-person were Jeff Schwab, Jeremy Spann, Lorita Bill, Nick Schenkel, Rosanne Altstatt, Pete Bill, Jeff Burnworth, H. Kory Cooper, David Hovde, Bridget Slack, John Thieme, Whitney Walton and Todd White.

Governor Jillian White attended online to establish a quorum for business.

Governors who were not present in person or online were, Cassandra Apuzzo, Colby Bartlet, Del Bartlett, Walt Griffin, Ashima Krishna, Quentin Robinson, Dave Sattler, and Tara Raber.

Executive Director Claire Eagle, Kelly Lippie, Brooke Sauter and Lucy Lugo were preset in person; Trey Gorden attended online.

**The Minutes** of August 26, Board Meeting were presented. They were corrected to note that Bridget Slack was in attendance and approved with a motion and a second from Pete Bill and Todd White.

**President Schwab** announced the board will accept nominations for the Ball Sholty Award in November; the award will be awarded at the 2026 annual meeting.

He reminded us TCHA will offer (its first) Winter Warmer for members on the afternoon of the Christmas Parade; the History Center will welcome members from 4 to 6 pm. Board members were encouraged to volunteer to help with the program.

He announced as well that the 2026 TCHA Annual Meeting will be held at 2 pm on February 7 at the History Center.

**The Vice President** reported he as begun the board member recruitment process, seeking a diverse, skilled and engaged board to propose to the membership at the Annual Meeting. He encouraged us to nominate possible board members over the next few weeks for consideration by the nominating committee.

**The Secretary** had nothing additional to report.

**The Treasurer** presented her Report (see attached), noting that TCHA has \$158,730 more in Cash balances less current obligations than it did on September 30 of 2024. TCHA's net Operating Income for the nine months ending September 30 was \$104,951 ahead of budget. Indeed, at one point soon after the Feast concluded TCHA had over \$1.2 million in cash on hand. This was before expenses were paid.

She credited more sponsorship, and an additional Taste of the Past dinner as reasons for the more successful financial situation as of September 30.

Claire Eagle presented the **Executive Director's Report** (see attached). She reported she has awarded Kelly, Trey and herself three (3) comp days for the extra time worked during leading up to the Feast this year.

She has begun the annual staff evaluation process and noted TCHA sites and offices will be closed November 27 and 28 for Thanksgiving.

She reported on TCHA programs, facilities grants and donations and upcoming events at which she will be representing TCHA.

She concluded her report by noting she had a somewhat contentious phone call with Mike Gibson, owner of Mulhaupts who expressed his displeasure that Mulhaupts was not included in the new book "200 years of Tippecanoe County – A Community Tells Its Stories". After discussion the board agreed no follow up from the EC was needed. As a letter was sent to each TCHA board member from Mr. Gibson it was agreed that the board president will follow up with an appropriate letter on behalf of the TCHA board.

Trey Gorden reviewed his written report for the **Battlefield Museum** (see attached), noting visitors have decreased a bit since last month, A new volunteer, Susan Bryant will work occasional weekends at the Museum.

The annual Commemoration of the Battle of Tippecanoe is scheduled for November 1; Dr. Gorden as well as others will speak to those who attend the day-long event.

Kelly Lippie reported for the **Membership Committee** (see attached). She noted the mailing of the 3<sup>rd</sup> Newsletter for the year and that several new memberships were received at the Feast. She attended Latino Fest and Holy Trinity Lutheran Community Day to promote TCHA and membership.

Kelly Lippie reported for the **Collections Department** (see attached), noting that several TCHA materials including the Bicentennial banners are/will be on display at locations in the community.

Nine items were recommended for removal from TCHA's Collections by the Collections committee (they were on display for the board members to review). Upon a motion by Pete Bill and seconded by Kory Cooper the board voted to de-accession the items.

**Lucy Lugo**, TCHA's new librarian, reported for the **TCHA Library** (see attached). The TCHA sponsored tour of Spring Vale Cemetery on October 26 was well attended with over fifty cars counted.

Research work for and with TCHA members and others kept her and volunteers busy the past month.

Ms. Lugo thanked her predecessor (and now volunteer) Amy Harbor for her mentorship; Amy sent a message to the Board that read" "Thank you to the Board for the opportunity to serve as Library Coordinator for the last several years. I look forward to helping Lucy however I can as I remain a volunteer in the library."

Brooke Sauter announced an OUTSTANDING FEAST! as she reviewed the **Feast of the Hunters' Moon Committee** report (see attached). An in-depth report was provided, from successes with ticket sales (both online and in person), food management, school days, and local news coverage from Based in Lafayette (Dave Bangert) and the Purdue Exponent called out.

Highlights from this year's Feast included hosting an unofficial visit form Charlotte Montel, the new French Consul General to the Midwest. Too, the Middlesex County Volunteer Fife and Drum Corp from Massachusetts joined the Feast at their request.

Board members suggested that TCHA share the known and estimated economic impact on the local community from the Feast with local government and economic agencies

#### **OTHER COMMITTEE REPORTS** were reviewed (see attached).

Claire Eagle reported for the **Development and Membership Committee.** The committee is planning the membership event to be offered at the History Center during the annual Greater Lafayette Christmas Parade.

The Annual Appeal has been mailed; the Development Plan is on track.

Jeff Burnworth reported for the **Facilities Committee**, reporting upon a number of topics including budget savings, grant income, repairs and upgrades at Arganbright, the Battlefield, the Fort, and the History Center.

Problems or challenges with the TCHA web server, the Church group meeting at the History Center and a floor drain at the History Center were noted and there are plans being implemented to respond to all of these concerns.

Jeff Schwab reported for the **Historic Markers Committee.** The new William Digby Historical marker for Greenbush has arrived; the installation location is TBD.

Kory Cooper reported for the **Ouiatenon Preserve Committee.** The committee is asking the TCHA board for permission to use funds from the restricted OP account to hire Brooke Sauter to design interpretive signage for the OP. It was noted that creation and installation of the signs will be a separate project and cost. It is the goal of the committee to have the finished signs in place before the 2026 Feast of the Hunter's Moon.

After discussion a motion to allow the expenditure not to exceed four thousand six hundred dollars (\$4,600) was proposed by Pete Bill and seconded by Jeremy Spann. The Board approved the motion by an oral vote; there was one "no" vote.

Executive Director Claire Eagle reported there are still food items for sale after the conclusion of the Feast. Please talk to Claire if you are interested in purchasing any of the food items.

President Schwab called the Board's attention to the latest **Strategic Plan Group Reports** from August and September (please see the attached documents).

There being no further business, Board member Pete Bill moved adjournment. The Board adjourned at 6:52 pm.
