#### EZEKIEL MERRILL TALBOT COLLECTION

#### INTRODUCTION TO COLLECTION

The Ezekiel Merrill Talbot Collection was donated by Dan N. Hansell, former resident and owner of 324 Tinkler Street in Lafayette. The Tinkler property was purchased by Barnett(?) Irving Johnston in 1887. After Johnston's death in 1930, the home was owned by his daughter, Altha Johnston Childers and her husband. The property was eventually bequesthed to Dan and Mae Hansell. The contents of this collection were probably found in the house by the Hansells; Mr. Hansell arranged the materials in two scrapbook/albums. For storage and conservation of the items, they were removed from the albums when the collection was processed.

Ezekiel Merrill Talbot was a civil engineer for the town of Lafayette (ca. 1875-78, according to the 1878 county atlas). Talbot platted Purdue University; he determined the placement of the wrought-iron fence at the Tippecanoe Battlefield. He also was chief engineer of the construction of the Cincinnati, Lafayette & Chicago Railroad and of the Lafayette, Muncie, & Bloomington Railroad. Prior to coming to Lafayette, Mr. Talbot was city engineer of Peru, Indiana (he is listed in the 1871-72 Lafayette City Directory). In 1848, E. M. Talbot married Nancy Whitman Talbot; their daughter, Nancy (Nannie) Talbot became the wife of Barnett Irving Johnston.
