#### INTRODUCTION

The Harris-Haile-Coffroth Collection was donated to TCHA in two increments, the first in 1980 and the second in 1982, by Sara and John Jamison, 620 Ridgewood Drive, West Lafayette.

The collection of letters and other papers belonged to Genelle Haile Coffroth ( -1969?) who was a neighbor (620 Ridgewood Drive when the Jamisons lived at 616 Ridgewood Drive) and friend of the Jamisons.

Genelle Haile Coffroth was the daughter of Alice Clopton Harris and Boykin M[a]cCaa Haille, native of Alabama and resident of Lafayette from 1915 until his death; her maternal grandparents were Josephine Terry and Benjamin T. Harris of Austin County, Texas. In 1919 she married William Randolph Coffroth of Lafayette.

The bulk of the collection consists of letters written by Benjamin T. Harris, an officer in the 16<sup>th</sup> Texas Infantry; the letters date from May 1852, shortly after the company's organization at Camp Grace near Hampstead, Austin County, Texas, to March 1864.

Also included in the collection are family and genealogical materials, primarily relating to Mrs. Coffroth's family with notes and items re the Clopton, Terry and Haile families.
