This index gives names appearing in the Final Record Books of the Probate Court of Tippecanoe County, Indiana. A named person may be the deceased, an administrator, or an heir. The year given is the year of the proceedings, which is usually different from the year of death. Probate Court did not exist after 1852, and estate matters were handled initially by the Court of Common Pleas and later by the Circuit Court.
